Five Arches Bridge It's a sad reflection of our society that some irresponsible people don't believe the by-laws on the Meadows apply to them. An example of this is the jumping off Five Arches Bridge into the Lake. Notices telling people that they are not allowed in the Lake, which is a Nature Reserve, are prominently displayed. Apart from the disturbance to the wild life the areas in the Lake below the bridge are very shallow. Unfortunately, one young lady found this out to her cost when she jumped in during the recent fine weather and suffered a broken leg. The incident was attended by Ambulance, Fire Service and Police and whilst they dealt with the incident other young people continued to jump off the bridge and when advised how dangerous it was were abusive to the emergency services. What is more disturbing, we understand, is that some of the parents who were there didn't think their children were doing any harm. Fencing was subsequently put up to dissuade people from doing it only to be pulled down the following day (see picture).

Tim Barnes - Trees & Woodlands Officer

I have taken over from Philip Louis as The Parks and Open Spaces Tree Officer for the London Borough of Bexley. Currently I have been conducting surveys across the entirety of Foots Cray Meadows with a focus on completing our newly implemented scheme as follows:

Category 1 - Trees within or in falling distance of playground's – Every Year

Category 2 - Trees adjacent to highways or train lines – Every 2 Years

Category 3 - Trees adjacent to pathways and water courses – Every 3 Years

Category 4 - Trees adjacent to residential properties – Every 4 years

Category 5 - Trees within woodland areas – Every 5 years

As you can imagine this will be a steep hill to climb with the number of parks we have in the borough and with the current pandemic slowing our progress at the beginning of the year. However, I hope to hit the ground running now that a return to normality is beginning and I hope to address a number of glaring issues within Foots Cray Meadows.

Firstly, before any aesthetic work is addressed, my primary goal is the removal of any unsafe material within categories 1,2 and 3. Most of the work I have already planned is the removal of deadwood over major paths, play equipment, or car parking areas. Unfortunately, there are an awful lot of paths with dangerous trees that need addressing and this will take some to get through. The removal of trees is a final resort and, where possible, we will be leaving stumps as a monolith to maintain habitat for wildlife.

My second objective is the retention of any of our mature tree stock. Some of our historic avenues of trees are suffering from die back and/or a lack of vitality. Trees of note include half a dozen Mature Oak trees which run adjacent to "The Burning Path" which are not as healthy as I would like them to be and I feel could benefit from some remedial action. In partnership with my colleague Patrick English on the Grounds Maintenance team I hope to initiate a plan to remove/ cut back the long-overgrown weed vegetation along this path and make room for wood bark mulch to be placed around the base of each tree that needs it. It is my hope that our contractors will be able to provide all the bark mulch we need from within the site itself and then place it in the desired areas. If possible, I would like to ask if you and your team of volunteers for their assistance of spreading the bark mulch to create a 3inch layer around the selected trees. This will be deep enough to allow a good amount of nutrients to be absorbed by the trees, whilst still allowing for the natural growth of blue bells underneath the Oaks and allow

them to continue their natural symbiotic relationship. With any luck the trees will find a new lease of life and we will be able to retain them for decades (if not centuries) to come.

Our only hurdle with this operation is the current Pest and Disease issues we have on the site and I am currently in talks with the Forestry Commission to ask them if this is a viable plan. If they are able to sign off this work, we can expect this to commence in the coming months.

Apologies for the shortened version of this Newsletter but we have not been able to undertake any activities for the past few months. Hopefully this will soon change.
